Todd introduced Assemblywoman Marjorie Byrnes. Marjorie Byrnes is a member of the New York State Assembly, representing District 133. Byrnes was recently elected to the office at general election of 2018.

Byrnes briefly reviewed her political resume in judicial systems leading to her recent election as assemblywoman. Tom Kopp asked about government budget expectation from Albany and budget transparency. Todd Galton reviewed the tri-board meetings efforts of finding a shared service of all three entities.

It was discussed that the Town of Nunda is in preparations of obtaining a new Highway garage. It was also discussed that in 2017 the Town, Village and School tried to make a highway garage a shared service for all entities and it didn't seem a functional possibility. All three entities are supportive of shared services where it makes sense. Jim Forrester stated sharing a highway mechanic would be more a reasonable possibility of a shared service for all three, but location and resources is a very difficult shared service to achieve successfully.

It was stated how KCS has six towns and three counties within its district. It cannot just propose a shared service to Nunda entities and none to the rest within its district.

Mayor Jack Morgan asked if the other entities of with KCS district were invited to this meeting? The answer was no.

Jim suggested a strategic planning of shared services from each entity would be the way to move forward to accomplish goals.
