## **LOCAL LAW NO. 1-2008**

**SECTION 1.** This Local Law is adopted pursuant to the authorization granted by Real Property Tax Law 458-b. All definitions, terms and conditions of such statute shall apply to this local law.

SECTION 2. Qualifying residential real property owned by a Cold War Veteran, or other qualified owner, shall be entitled to a partial exemption from taxation to the extent of 15% of the assessed valuation, not to exceed \$12,000.00 or the product of \$12,000.00 multiplied by the latest State equalization rate. Additionally, where the Cold War Veteran received a compensation rating from the United States veterans affairs or from the United States department of defense because of a service connected disability, qualifying residential real property shall be exempt from taxation to the extent of the product of the assessed value of such property, multiplied by fifty percent of the Cold War Veteran disability rating, not to exceed Forty Thousand Dollars or the product of Forty Thousand Dollars multiplied by the latest State equalization rate.

**SECTION 3.** This local law shall take effect immediately upon its filing in the Office of Secretary of State and be effective with the 2009 assessment roll.
